


Governance, Control and Decision-Making Responsibilities: The Framework for Change

- An explicit and unequivocal demand for an increased level of responsibility from boards, board committees and senior management
- An explicit requirement that board and management positions be understood to be positions of service and not of entitlement



Forces at Work: in Sequence... And in Parallel



Corporate Governance ...

- Democracy is a continuing experiment. The evolution of corporate governance within a democracy is a subset of that experiment.

Governance and Controls – Process Driven

- Tone at the Top v. Checks & Balances
 - Statement v. Process
 - Walgreen's Theranos
 - State Public Employees Retirement System
- The Division of Labor is specific to a firm at a point in time
 - Governance, Control and Decision-making structures are specific to a firm
 - Best practices may be worthless
- Good decision-making processes may experience bad outcomes



Tone at the Top Statements

- "We are offended by the perception that we would waste the resources of a company that is a major part of our life and livelihood, and that we would be happy with directors who would permit that waste. …So as a CEO, I want a strong, competent board."
- "It's more than just dollars. You've got to give back to the community that supported you."
- "You'll see people who in the early days... took their life savings and trusted this company with their money. And I have an awesome responsibility to those people to make sure that they've done right."
- "Boards should be absolutely certain that the company is run properly from a fiduciary standpoint in every degree. I am a great believer in the audit committee having full access to the auditors in every way, shape, and form."

Tone at the Top Statements

- "It's more than just dollars. You've got to give back to the community that supported you." Adelphia founder John Rigas (convicted in February 2005 on 18 counts of fraud)
- "You'll see people who in the early days... took their life savings and trusted this company with their money. And I have an awesome responsibility to those people to make sure that they've done right." former WorldCom CEO Bernard Ebbers (convicted in March 2005 on nine counts of fraud sentenced to 25 years in Federal penitentiary)
- "Boards should be absolutely certain that the company is run properly from a fiduciary standpoint in every degree. I am a great believer in the audit committee having full access to the auditors in every way, shape, and form." **former Sunbeam Chairman Al Dunlap**
- "People have an obligation to dissent in this company." Former Enron CEO Jeffrey Skilling (sentenced to 24 years, four months in Federal penitentiary)

The Role of the Board – Two Views

The Delaware Courts

- Retired Delaware Supreme Court Chief Justice E. Norman Veasey, in his Pennsylvania Law Review article, states that stockholders should have the right to expect that "the board of directors will actually direct and monitor the management of the company, including strategic business and fundamental structural changes."
- Chancellor William B. Chandler, in his highly regarded Disney Opinion, states, "Delaware law is clear that the business and affairs of a corporation are managed by or under the direction of its board of directors. The business judgment rule serves to protect and promote the role of the board as the ultimate manager of the corporation."

The Business Roundtable

- "Business Roundtable supports the following guiding principles: First, the paramount duty of the board of directors of a public corporation is to select a chief executive officer and to oversee the CEO and senior management in the competent and ethical operation of the corporation on a day-to-day basis..."






